Dear Brothers, celebrating the Memorial Mass at our 126th convention the following words of St. Augustine came to mind in preparing for the Memorial Mass. My homily introduced this message by the Doctor of Grace, interspersed with my own reflections. Here I would like to offer some of the sermon, and my brief reflections follow.

"We read in the Proverbs of Solomon: *If you sit down to eat at the table of a ruler, observe carefully*" what is set before you; then stretch out your hand, knowing that you must provide the same kind of meal yourself. What is this ruler's table if not the one at which we receive the body and blood of him who laid down his life for us? What does it mean to sit at this table if not to approach it with humility? What does it mean to observe carefully what is set before you if not to meditate devoutly on so great a gift? What does it mean to stretch out one's hand, knowing that one must provide the same kind of meal oneself, if not what I have just said: as Christ laid down his life for us, so we in our turn ought to lay down our lives for our brothers? This is what the apostle Paul said: Christ suffered for us, leaving us an example, that we might follow in his footsteps. This is what is meant by providing "the same kind of meal." This is what the blessed martyrs did with such burning love. If we are to give true meaning to our celebration of their memorials, to our approaching the Lord's table in the very banquet at which they were fed, we must, like them, provide "the same kind of meal. At this table of the Lord we do not commemorate the martyrs in the same way as we commemorate others who rest in peace. We do not pray for the martyrs as we pray for those others, rather, they pray for us, that we may follow in his footsteps. They practiced the perfect love of which the Lord said there could be none greater. They provided "the same kind of meal" as they had themselves received at the Lord's table."

These beautiful words set two images side by said as mirror images. The King of Kings laid out a banquet of food before us. He also laid down his life for us. We eat of this banquet. We consume the example of his love. Where St. Augustine speaks of the martyrs "who pray for us," we now have all the canonized saints, who ate of the Lord's banquet, who imitated the example of his love, and who pray for us that we can all do the same.


Brothers,



Notes for the closing of 2nd half FY 2023-2024, months May and June 2024

Here are some ideas for reaching membership goals:

- Develop a list of prospects and assign two men per prospect to recruit them.
- Order some KofC hats that can be worn at Mass, with Fr.'s permission.
- 3. Hold an information night to explain fraternal benefits. Invite Field Rep David Giuliani. Hold one in May and one in June.
- 4. Hold two church drives, one in May and one in June.
- 5. Use brochure: "Why Join" at church drives.
- Send a letter signed by you and Fr. inviting prospects to join.
 Suggest they review Knights of Columbus Web
 Link kofc.org/JoinUs and further suggest they join your Council.
- 7. Use the church bulletin to run weekly articles in the bulletin. Use extracts from brochure "Why Join" for a short paragraph weekly to keep the focus on recruiting
- When recruiting, it's important to: know who you are recruiting, the tools to be used, where recruiting is taking place, and praise those having success.

The State's goal for FY 2023-2024 is 121. We currently have recruited 94 new members. We need 27 new members (121-94=27) before 30 June 2024.

I've been informed that our recruiting success of 94 (as of 2 May 2024) has of this date been the highest ever achieved, compared to past performances of the same time frames. WOW! Come 30 June 2024 we could have a winning record (121) achieved only once in the past (FY2021-2022). So, let's get our recruiting teams recruiting!

You need to come up with at least one new member before 30 June! The only thing preventing you from becoming a dynamic Grand Knight is bringing on board new members.

Convention Message

This year's convention is behind us and there is so much happening with the KofC that should be shared with the councils. In your message to our brothers, be sure to mention the opportunity for a career with the Knights of Columbus. For those of you who missed it, my main point at the convention was the need for another agent here in VT.



Worthy Grand Knights, Faithful Navigators and my Brother Knights,

I am presently coordinating two Icons.

The first is the St. Joseph Pilgrim Icon, the latest in a series of Pilgrim Icons since 1979. The Icon itself is a large (30" x 36") framed painting. The Pilgrim Icons are a Faith activity in the Faith in Action program, and every 3-4 years Supreme comes out with a new one to send to each state. We have two; one is up in the NEK right now and the other is sitting at my house. So, between those two, I should be able to get one to you most anytime you wish. The St. Joseph Pilgrim Icon comes with prayer service booklets. The Prayer Service includes reciting the Holy Rosary. It can also be coupled with a Mass if your Chaplain wishes.







The second Icon is the Silver Rose. The Silver Rose is an actual rose made of silver (see below). The Silver Rose is a Life activity in the Faith in Action program. It promotes the dignity of and respect for life, and honors Our Lady of Gaudalupe. There are 8 Silver Roses which each year travel assigned routes throughout Canada, the U.S. and Mexico. We will be receiving our Silver Rose from NH on July 14 and will have it until August 3 when we transfer it to MA. So it is only available here in VT during that 3-week period in late July. It also comes with prayer service booklets similar to the Pilgrim Icon. If your Council would like to sponsor a Silver Rose service in late July, let me know of the date(s) that you are thinking of. Several Councils have already expressed an interest, and I will try my best to accommodate everyone. Usually that is not a problem though.

Fr. Pio Mandato Retreat Weekend & Healing Service with St. Padre Pio Relic



Fr. Pio Mandato is a Capuchin priest whose mother, Graziella DeNunzio Mandato, was a spiritual child of St. Padre Pio and wrote a memoir about him. Fr Mandato was named after the saint and, like St. Pio, traces his roots back to the village of Pietrelcina in southern Italy. Fr Mandato received his first Holy Communion from St. Padre Pio. His family migrated to America and at 17 Fr Mandato entered the Capuchins and was ordinated in 1985 offering his first mass at the same altar as St. Padre Pio. He became involved in hospital chaplaincy and developed a reputation for devotion to the sick like St Pio.

In 1998, after serving for 13 years as a Capuchin, Fr Mandato began to lead a life of prayer and solitude as a missionary hermit in the Diocese of Scranton. He now takes breaks from the eremitical life to travel around preaching and offering healing Masses for the sick.

Fr Pio Mandato will be hosting a weekend retreat at Christ the King/St Anthony Parish in Burlington. A healing service with a relic of St Pio will be held at St Anthony on Friday May 24th, 6-7:30 PM. A retreat day Saturday May 25th at Christ the King will include mass, reconciliation, adoration, praying the rosary, relic veneration and blessing, and a talk by Fr Pio Mandato. He will be co-celebrating weekend masses and blessing with the relic after.

Middlebury Council 642 held a pancake breakfast on April 21.





Let's Get Social!



As in social baldrics. Because there's been some changes lately and despite best efforts to communicate these changes, it seems that the message never quite makes it down to the membership or often gets jumbled along the way. So, I am committing this month's Supreme Master's message to explaining the changes in a Frequently Asked Questions (FAQ) format. So, here we go!

1. Why did the social baldric go away?

Answer: It has not gone away. Instead, it will no longer be given out to new members at an exemplification.

2. Why was this change made?

Answer:

With shipping and handling, the cost of a social baldric eats up approximately 20-25% of the exemplification fee to provide a baldric that will seldom if ever be used again. For one, it does not go with the current uniform, as it was de signed for wear with a tuxedo. Two, when it's given to new members completing the degree in a military, law enforce ment or firefighter dress uniform, it is not authorized and does not fit with the uniform at all.

Who can still wear the social baldric?

Answer:

Any member. Most importantly, those members who still use the tuxedo because they have not been able to acquire the new uniform yet actively participate in the Fourth Degree. This policy change is not intended to make such members feel excluded. New members have the option to buy one for wear at black tie functions requiring a tuxedo, e.g. state or supreme conventions. However, the use of the social baldric with a tuxedo is not mandatory but a way for a member to show pride in their Fourth Degree membership.

4. Can districts or assemblies purchase social baldrics as gifts to new members?

Answer: Yes. Although, it would not seem to be a very practical financial decision considering how seldom they are used any

more.

5. What is the dress code for the Patriotic Degree?

Answer: The preferred dress code is the new official uniform with beret. However, if the candidate does not have the new Cont.—Supreme Master on Page 2

uniform, they may wear a dark suit and tie.

6. May new candidates wear tuxedos for the Patriotic Degree?

Answer: No – effective July 1, 2024, as it makes no sense to buy or rent a tuxedo for a degree. The expense of purchasing or

renting could be used instead to offset the cost of a new uniform.

7. Can mixed honor guards occur where some members still wear their tuxedo and social baldric, and others wear the new un-

form?

Answer: No, as it does not lend to uniformity. Honor guards are limited to the new uniform.

8. What is the District Master's Fund and how does this change impact it?

Answer:

District Masters are not reimbursed by the Supreme Assembly except in very rare cases. As such, the Master must carefully plan travel to visit assemblies and to conduct degrees. Last year, the Board of Directors voted to increase the exemplification fee to \$90, meaning that a district <u>may</u> charge up to that amount. Masters often lose money carrying out their duties. Between travel and degrees, many use their own money to keep the Fourth Degree going. Simply put, this is not right! By increasing the fee and eliminating the social baldric for new candidates, it increases the Master's ability to conduct a meaningful degree, Mass, and banquet without going in debt. Essentially, it provides relief to dedicated Sir Knights who are giving significant time and leadership to the Fourth Degree.

9. What is the change with name badges?

Answer:

Previously, no name badges were worn with the current uniform, and this creates a bit of confusion. Especially in social settings where nobody knows the names of attendees from other assemblies, etc. To remedy this, members may now wear a Fourth Degree name badge with the current uniform <u>ONLY</u> in a social setting and <u>NEVER</u> in an honor guard. Since the embroidered emblem on the left breast and wear of medals prevents wearing a badge on the left, the name badge may be worn on the right breast, using either a pin or magnetic backing.

10. May I wear any name badge?

Answer:

No. It must be the Fourth Degree name badge for your assembly or one that designates your current rank, including past or former FN, FF, DM or VSM ranks. There is no requirement to purchase a specific name badge for wear and you may even add a magnetic backing to your current badge instead of incurring additional costs.

11. Are there any exceptions for wearing a Third Degree name badge?

Answer:

Yes – <u>current</u> State Officers (including District Deputies) may wear the badge for their respective office. The same rule applies to <u>current</u> Supreme Officers and Directors. Past Supreme Knights, Immediate and Past State Deputies, Former State Chaplains, and Former Supreme Directors, may wear their respective badge indefinitely.

Manual of the Sword Present Sword

At a recent call out, I noticed a lack of uniformity in how the members of the Honor Guard held their swords. Please work with your FNs to make sure everyone correctly presents their sword. Here is how we do it.

Present Sword

- 1. This command is used to salute with the sword. It is used when the unit is presented to the colors, to any person, or when the *National Anthem* or *To the Colors* is played.
- The preparatory command for this order is "Present."
- 3. At the command of execution, "Sword," raise and move the sword to the front, bringing the hilt of the sword to the center of the chin with the guard flange to the front.
- 4. As the sword is placed at the center of the chin, allow the flat side of the blade to extend on an angle away from the face of the holder, keeping all of the swords for all of the unit consistent and in a straight line, the thumb on the grip directly behind the guard and the remaining fingers grasping the grip firmly and the right elbow resting against the body. (See Figures 14, 15 and 16.)

Korean & Vietnam War Census Program

The Fourth Degree will conduct a census of the membership to establish a record of service in both the Korean and Vietnam Wars.

During both World Wars, the Order documented war service by its members in the archives at the Blessed Michael

J. McGivney Pilgrimage Center. However, similar efforts were not conducted following either the Korean or Vietnam Wars.

The Korean War commenced in 1950, making the approximate minimum age of surviving veterans ninety-one years old. The approximate minimum age of surviving Vietnam veterans serving from 1965-1973 is 69-77 years old. Both the Korean and Vietnam Wars marked a significant departure in how troops served and returned from war, as service was no longer for the duration. Gone were the hero's welcome on return. Vietnam veterans returned to a hostile and divided nation, where they were either overlooked or criticized for their service.

Assemblies working in conjunction with their assigned councils will conduct a census of their membership using the attached form. Where possible, documented service of deceased members needs to be recorded. Inclusion in the census shall be limited to veterans meeting the requirements established by Congress for the Korean Service Medal you must have served from June 25, 1950 to July 27, 1953, and have been on permanent assignment or on temporary duty for 30 consecutive days or 60 non-consecutive days and performed his duty within the country of Korea. For the Vietnam Service Medals, you must of served from July 3 1965 to March 28 1973 and have been on temporary duty for at least 30 consecutive days or 60 non-consecutive days or have served in combat with a unit directly supporting a military operation in Southeast Asia (Vietnam and the contiguous waters and airspace in Thailand, Laos, or Cambodia; or the airspace thereof and in the direct support of military operations in Vietnam.

This project would be an excellent opportunity for all the District Masters to collaborate with the State Deputy to schedule a Memorial Mass in the spring of 2025, in one of the jurisdictions cathedrals or basilicas to mark the 50th Anniversary of the end of the Vietnam War. In planning the event, jurisdictions should consider how to invite all Brother Knights who are Korean or Vietnam War veterans.

The Mass could be followed by the placing of a wreath at a local Korean or Vietnam War Memorial by the jurisdiction's State Deputy, State Officers, Vice Supreme Master, District Master, and Past State Deputies with the escort of a Fourth Degree Honor Guard. For all assemblies who cannot participate at your local basilica or cathedral, they should collaborate with their councils to have a local Mass, or Masses during the spring of 2025.

Certificates recognizing service will be delivered to surviving veterans via their councils. For District Masters, it is recommended that you reach out to all your Faithful Navigators to collaborate with their local Grand Knights to hold a party or dinner for those veterans receiving the certificate. There should also be a Fourth Degree Honor Guard present during the certificate presentation. Let us show our appreciation to those veterans in our council who served in these two wars and to let them know that their sacrifices are not forgotten.

CT ASSEMBLY HELPS HOMELESS VETERANS

The Father James Larkin Assembly 3627 collected toiletries for veterans living at the "Homes for The Brave" at the St. Agnes and St. Mary Masses on 23 & 24 March 2024 (Parish of Precious Blood). The Homes for The Brave's mission is to provide shelter, support & hope to our nation's brave veterans who served our country. The items were delivered to the "Home" in Bridgeport on 25 March by FN Art Sutton and FC Pat Eisenman.

The "Home" is a 42-bed transitional housing program available to male veterans and non-veterans who are homeless. It provides housing, case management and vocational services.

They also operate The PFC Nicholas A. Madaras Home, a communitybased 14-bed transitional home for women veterans experiencing homelessness; Homes for the Brave in West Haven, a transitional housing program, consisting of two houses, for male veterans who are homeless: the Waldorf Permanent Supportive Housing which provides 9 units of permanent supportive housing with case management services to former homeless veterans; and a walk-in/drop-in Veterans Service Center (VSC) offering immediate basic need services and referrals to long-term services to any homeless or at risk of being homeless veteran. The VSC also provides vocational services to any homeless veteran at our transitional housing program.
