

This will allow you to get all of your info down as you complete it and have it still fresh in your mind. Use the Form # STSP to record info and PLEASE submit a separate write up and pictures to increase your chances of winning an award at the State Convention. We don't do programs to get praise or recognition, but is nice when we are rewarded for the good deeds we do. The cutoff for submissions to me is March 29, 2025. The State judging committee will be meeting in the first week of April to determine the winners in each category.

Please mail to me if possible, e-mail is OK as well, but I only have a black & white laser printer and you won't get as nice a presentation. I will accept ALL submissions for any award submissions in the 4 categories:

-FAITH, FAMILY, COMMUNITY, LIFE

There are forms attached for Blessed Michael McGivney-Chaplain of the year award and I will also be accepting nominations for Family of the Year and Knight of the Year as well, these forms are attached as well. I think each Council should have no problem having a nomination for all 3 of those categories, as all of your Councils certainly have a Worthy Chaplain, Brother Knight and Family, which easily meet those criteria. The forms are simple and pictures and testimonials certainly help.

Also, your FS should submit to me the longest continuous serving Brother from your Council so that he can be recognized . This award is for continuous service , not First Degree date.

Please remember that the Star Council requirements for this Fraternal year, they are:

Columbian Award — for the Programs you all do ,reported on Form# SP-7 by June 30. Categories listed above and complete 4 programs in each category , 16 total required , Featured programs = 2 points each McGivney Award — for Membership . 5% increase over last years member number on your roster. Founders Award — for Insurance . No quota this year , Council must participate in at least 2 Online or in person approved Insurance benefit informational meetings . Must have 10 members in attendance. Council must submit form # 11077 .

Safe Environment training - Required for specified leadership positions: Grand Knight , Community , Program and Family Directors. This applies to Columbian and State Awards , please make sure you are compliant to be considered.

Also , Form #365 Service Program Personnel report and Form #1728 Annual Survey for Fraternal Activity must be submitted and all assessments paid to Supreme and State Councils. Please submit your awards for consideration , it is not too early , Good Luck and Vivat Jesus! Fraternally ,

To qualify you must be a high school senior qualifying to graduate in June 2025 AND a son or daughter of a Knight of Columbus member (paternal or legally adopted) in good standing in a subordinate Council within the Vermont jurisdiction. Sons or daughters of deceased members are also eligible if their father was in good standing at the time of his death. An applicant may be a member of the Knights of Columbus or a member of a Columbian Squires Circle, in the jurisdiction of Vermont and a high school senior qualifying to graduate in June 2025.

Five \$1,000.00 scholarships will be given by the Vermont Knights of Columbus to assist recipients with their education at an accredited school or college of their choice.

Applications must be returned to the Chairman, at the address above, by March 7, 2025 to qualify for an award.

The application is in two parts with the major portion of Part II being completed by your school personnel. Therefore, we strongly suggest Part II be given to your school personnel <u>immediately</u> to allow the maximum time to prepare their part of the application.

The filing date should be brought to the attention of the guidance personnel of your school, since delinquent applications may disqualify an applicant from consideration for an award.

Failure to submit your essay may also result in the application being invalidated.

Scholarships not claimed by February 15, 2026 will be forfeited and the prize will be given to the next alternate on the list.




Join thousands of Catholics across North America in asking for Our Lady of Guadalupe's intercession through the Silver Rose program.

District Master Letter



Worthy Sir Knights,

It is with great pleasure on behalf of my wife Karen and I as District Master of Bishop James A. Healy Province, Vermont Jurisdiction, to congratulate our newest January 2025 class of 4th Degree members of the Knights of Columbus and our District. The Fourth Degree was established on February 22, 1900 on the principles of patriotism, love, and devotion to one's country. Fourth Degree Knights, or Sir Knights focus the majority of their activities on this principle. It is the highest and most prestigious degree with the Knights of Columbus. You now noted amongst a group of outstanding Knights, dedicated

to the service of the church, our country, and our Order. This February 22, 2025 we will be celebrating One Hundred and Twenty-Five years of the Fourth Degree in New York City at St. Patrick Cathedral.

The emblem you now wear is proof of your commitment to conduct your lives honorably and patriotically in public as well as in private. The sacred symbols of the emblem epitomize the union of the three divine persons in one God, the Blessed Trinity. By this emblem, may other others see your good work, which glorifies our holy religion, our honored order, and our beloved country. I ask that be active in your Assemblies' activities. Participate in your Assembly Color Corps and Honor Guard. Always keep the principles of our Order, charity, unity, fraternity, and patriotism uppermost in your lives.

On January 18, third-degree knights advanced to the honors of the fourth-degree. They give witness to their personal willingness to footer the virtue of patriotism in their lives. I offer my personal conventuals to each of them, and echo the good wishes conveyed on this happy occasion by their families and friends.

The virtue of patriotism – the love of and devotion to one's country – has its roots in the virtue of piety, a twin of the virtue of religion So it is that, as practical catholic men, the Knights of Columbus are loyal sons of their country and they are also a loyal son of their church.

This loyalty was embedded in the fabric of Columbians more than a century ago, on (WASHINGTON'S BIRTHDAY), February 22, 1900, When, for the first time, more than 1,100 Knights were exemplified in the newly established fourth degree.

From that day to this, Knights have aspired to be worthy of this degree, knowing, in concert with the resolution of the board of directors establishing the degree, that it should be conferred only on worthy and persevering members of the order. These are exciting times to be a knight of Columbus.

The fourth degree is celebrating more than a century of faith and a lifetime of loyalty, 125 years of defended liberty, while perpetuating freedom. The founding of the fourth degree launched. The founding of the fourthdegree launched a part of out order. The provided opportunities to excuse greater commitment to God and country. It has been said that the fourth-degree is the visible arm of the order. What an awesome responsibility rests on your shoulders when you put on the uniform and march into a church or a parade, present. The flag of our country at meeting, or stand guard at a wake. When you do, you represent not just the fourth-degree, but the order of the Knights of Columbus. Have you ever wondered why the baldric you are wear carries the order and not the emblem of the fourth-degree? The answer is because you are part, not apart from, the order of the Knights of Columbus. (You do not compete with council programs.) You complement them and their activities. You are the visible arm of the Knights of Columbus. It is especially pleasing to welcome these men to the ranks of the fourth- degree today, at a time when there is a resurgence of patriotism. But even when the idea of patriotism seemed outmoded; when some took the offensive against the notion of the love of country; when burning and/ or desecration of the national flag became the paramount action of protest, under the guise of free speech the Knights of Columbus. Never faltered in their dedication to the principle of patriotism. And today we stand steadfast in opposition to efforts to remove the words "under god" from the pledge of allegiance.

Today, our newest fourth-degree members become heirs to that tradition. In concert with their brothers throughout the order, they will strive mightily to ensure that the flag and God will enjoy the respect they deserve.

As I express my congratulations to you New Sir Knights, I also encourage you and your brother Sir Knights of longer standing, always to be conscious of the need to invite eligible third- degree members to join.

Presidents' Day is February 17, 2025, officially Washington's Birthday at the federal governmental level, is a holiday in the United States celebrated on the third Monday of February. It is often celebrated to honor all those who served as presidents of the United States and, since 1879, has been the federal holiday honoring Founding Father George Washington, who led the Continental Army to victory in the American Revolutionary War, presided at the Constitutional Convention of 1787, and served as the first U.S. president from 1789 to 1797.

George Washington was born on February 22, 1732 (N.S.). Washington's Birthday was celebrated on this date from 1879 until 1970. To give federal employees a three-day weekend, in 1968 the Uniform Monday Holiday Act moved it to the third Monday in February, which can occur from February 15 to the 21st. The day soon became known as Presidents Day the presence and placement of the apostrophe varies) and provides an occasion to remember all the U.S. presidents, to honor Abraham Lincoln's and Washington's birthdays together, or any single president of choice. As many states and cities followed suit, some states that had been celebrating Lincoln's birthday on February 12 combined the two into Presidents Day. Lincoln led the nation through the American Civil War, preserved the Union, abolished slavery, bolstered the federal government, and modernized the U.S. economy.
