STATE DEPUTY'S MESSAGE

Dear Brother Knights,

This coming week we will gather for Mass on Ash Wednesday and enter into the liturgical season of Lent. This special penitential period of forty-days before Easter helps us focus more closely on our relationship with God as we "die to ourselves" and put His will <u>first</u> in our lives. The Church recommends that we pray more deeply and often; occasionally deny our



our bodies the food and drink we crave, through abstinence and fasting; and become even more charitable by giving more of our time and money to those in need. These have been the spiritual "bestpractices" that Jesus himself demonstrated in His life, and holy men and women throughout the centuries have used to decrease their self-centeredness while increasing their connection with God and His Church. As Knights, we are men who readily engage in these spiritual practices and give of ourselves freely to serving others. Lent gives us a chance to do this even more passionately and completely. This process is similar to forging steel in fire – the metal, made malleable by intense heat, is repeatedly hammered and compressed until it assumes its desired shape and superior strength. This is the kind of dynamic transformation we are all called to encounter during Lent so, like the steel, we can be formed in the "shape" of Christ with greater spiritual strength and resolve in the practice of our Faith. As we try to do this for ourselves before Easter, we should also consider how we can help others to do the same. One of the greatest ways a Knight of Columbus can help another Catholic brother grow in his faith is by inviting him to pray, fast and give alms the way that we do as Knights. The most spiritually impactful way we, as Knights, can extend charity to others is by helping them grow in their faith. By doing so, we not only grow and strengthen our fellow Catholics, but also the Catholic Church in Vermont. As we humbly pursue our many Lenten practices, please consider how offering our fellowship to other Catholic men might be what God is calling us to give, and calling them to receive.

May God bless you and your families throughout these forty days!

-FAITH, FAMILY, COMMUNITY, LIFE

There are forms attached for Blessed Michael McGivney-Chaplain of the year award and I will also be accepting nominations for Family of the Year and Knight of the Year as well, these forms are attached as well. I think each Council should have no problem having a nomination for all 3 of those categories, as all of your Councils certainly have a Worthy Chaplain, Brother Knight and Family, which easily meet those criteria. The forms are simple and pictures and testimonials certainly help.

Also, your FS should submit to me the longest continuous serving Brother from your Council so that he can be recognized . This award is for continuous service, not First Degree date.

Please remember that the Star Council requirements for this Fraternal year, they are:

Columbian Award - for the Programs you all do ,reported on Form# SP-7 by June 30. Categories listed above and complete 4 programs in each category , 16 total required , Featured programs = 2 points each McGivney Award - for Membership . 5% increase over last years member number on your roster. Founders Award - for Insurance . No quota this year , Council must participate in at least 2 Online or in person approved Insurance benefit informational meetings . Must have 10 members in attendance. Council must submit form # 11077 .

Safe Environment training - Required for specified leadership positions: Grand Knight , Community , Program and Family Directors. This applies to Columbian and State Awards , please make sure you are compliant to be considered.

Also , Form #365 Service Program Personnel report and Form #1728 Annual Survey for Fraternal Activity must be submitted and all assessments paid to Supreme and State Councils. Please submit your awards for consideration , it is not too early , Good Luck and Vivat Jesus! Fraternally ,

To qualify you must be a high school senior qualifying to graduate in June 2025 AND a son or daughter of a Knight of Columbus member (paternal or legally adopted) in good standing in a subordinate Council within the Vermont jurisdiction. Sons or daughters of deceased members are also eligible if their father was in good standing at the time of his death. An applicant may be a member of the Knights of Columbus or a member of a Columbian Squires Circle, in the jurisdiction of Vermont and a high school senior qualifying to graduate in June 2025.

Five \$1,000.00 scholarships will be given by the Vermont Knights of Columbus to assist recipients with their education at an accredited school or college of their choice.

Applications must be returned to the Chairman, at the address above, by March 7, 2025 to qualify for an award.

The application is in two parts with the major portion of Part II being completed by your school personnel. Therefore, we strongly suggest Part II be given to your school personnel <u>immediately</u> to allow the maximum time to prepare their part of the application.

The filing date should be brought to the attention of the guidance personnel of your school, since delinquent applications may disqualify an applicant from consideration for an award.

Failure to submit your essay may also result in the application being invalidated.

Scholarships not claimed by February 15, 2026 will be forfeited and the prize will be given to the next alternate on the list.




Join thousands of Catholics across North America in asking for Our Lady of Guadalupe's intercession through the Silver Rose program.

VOCATIONS

Through the Refund Support Vocations Program (RSVP) the Knights of Columbus has cultivated this spiritual soil for more than 41 years. While the order has a number of vocations programs, RSVP is the primary program through which councils, assemblies and circles provide financial and moral support to men and women preparing for the priesthood or religious life, and every council, assembly and circle is encouraged to participate.

RSVP allows councils and assemblies to "adopt" one or more seminarians or postulants and provide them with financial assistance and moral support. The intent of RSVP is to demonstrate support for individual seminarians. RSVP support is not solely financial aid, and councils are asked not to base their support on the financial needs of the seminarian. All seminarians are worthy of support through RSVP by virtue of the fact that they are discerning a religious vocation, not because of their financial situation.

Please remember that with RSVP, Knights provide more than financial support; members write letters to the seminarians or postulants, sponsor dinners for them, invite them to join the council and, most importantly, pray for vocations.

Please support our seminarians through our RSVP program which is both moral and financial support. Under this program, councils and assemblies make an annual minimum donation of \$500 or more to an individual seminarian or postulant to help with expenses. The sum must go to a single qualified person; it may not be divided or apportioned to more than one recipient. Councils and assemblies can sponsor more then one seminarian or postulant if their resources permit. For every \$500 donated, the council or assembly is eligible for a refund of \$100. Our (RSVP) Scholarship money is used by seminarians and those in religious formation for books, car insurance and maintenance, travel during vacations, clerical clothing, emergency expenditures and other living expenses.

I ask that all our councils work with me as your State Vocations Chairman to ensure the proper and complete implementation of the RSVP program to ensure that every seminarian sponsored by the diocese is included in the RSVP program. THE GHOST ARMY PROJECT

The Ghost Army used inflatable tanks, sound effects, radio trickery, and imagination to fool the Germans on the battlefields of Europe. The "unsung" heroes of the 23rd Headquarters Special Troops and the 3133rd Signal Company Special carried out 25 battlefield deceptions in France, Luxembourg, Belgium, Germany & Italy. They saved 1000's of lives and helped win the war, but their efforts were kept secret for 50 years & were only recently officially recognized with the **award of a Congressional Gold Medal**. The mission of the Ghost Army Legacy Project is to preserve and honor the legacy of these men.
